# Ethiopia's **A G G** FP2030 Commitment



ETHIOPIA'S FAMILY PLANNING VISION FOR 2030: To see a healthy and prosperous society through increased access and utilization of contraceptive service.





1. Increase family planning (FP) service financing by continuing to earmark funds from the treasury and SDG fund; and track financing using the National Health Account

- Increase government allocation at all levels from general tax revenue.
- Enhance public private partnership (PPP) and translate the national PPP directive into action.
- Discuss and revise the Children's Behavioral Health Initiative (CBHI) benefit package to include FP services.
- Strengthen cooperation with development partners & international NGO support to improve funding for FP.
- Strengthen collaboration & involvement of local NGOs like regional development associations.



2. Improve contraceptive commodity security, increasing 'no stockout' status of at least 3 modern methods from 63% to 90%

- Building the capacity for human resources involved in the supply chain and logistics management system.
- Strengthening forecasting, supply planning and logistics management information system.
- Enhancing Reproductive Health Commodity Security coordination mechanism public private and non-profit sectors working on commodities and logistics.
- Strengthening monitoring and evaluation system for effective and data driven decision making for proper and efficient supply chain and logistical management.



3. Improve access to adolescent and youth responsive health system for contraceptive use, reducing pregnancy among adolescent girls from 13% to 7% by 2025 and 3% by 2030

- Expand and strengthen adolescents and youth friendly health services at all public health facilities including developmental corridors and youth centers.
- Enhance the competency of providers on adolescent and youth Sexual and Reproductive Health (SRH) issues.
- Conduct targeted national and regional advocacy campaigns on the prevention of teenage pregnancy and child marriage.
- Strengthen multi-sectoral coordination and collaboration to prevent/reduce teenage pregnancy.
- Enhance the development and dissemination of tailored SRH information and education.
- Enhance innovation and digital technology to increase access to contraceptive information and uptake.



#### 4. Ensure availability of quality and safe FP information and services to decrease unmet need for FP from 22% to 17% by 2030

- Increase demand for quality FP information and services through tailored Social and Behavior Change Communication (SBCC) initiatives.
- Ensure access to quality counselling and informed FP information and services with full method mix at all levels of the health system.
- Ensure the availability of a motivated competent and compassionate workforce for FP through Values Clarification and Attitude Transformation (VCAT), catchment-based mentorship & supportive supervision.
- Improve availability of quality post-partum and post-abortion FP service.
- Ensure FP service integration at health delivery points.

FP2030-dedicated focal points will also play a leading role in ensuring cooperation and effective implementation.





## OTHER ELEMENTS OF ETHIOPIA'S ACCOUNTABILITY APPROACH

**Visibility and transparency in sharing information:** Lessons learnt and challenges encountered during implementation will be shared among stakeholders through various forums and platforms. Civil society and other partners will be able to use the media and social media platforms to hold policymakers accountable.

- Alignment with other national commitment processes: This commitment is included in relevant national plans like the Health Sector Development II plan, Sustainable Development Goals (SDGs) and the plan to become a middle income country by 2030.
- **Remedial actions in case of rights violations/lack of progress:** Advocating for policy change will be part of the action. Immediate action will be considered if women and girl's rights are being violated.
